All committee members will have an equal voice in deliberations. The CAC typically meets eight times a year on Thursday mornings in the 1<sup>st</sup> Floor Community Room of the City/School Administration Center starting at 7:30 a.m. and generally last no longer than one hour. If you are appointed for a position, your nomination is subject to confirmation by the MPO's Executive Policy Committee and the information you provide on this form will then be available to the public and posted on the MPO's website.
